

# Fall 2014 Training for Substance Abuse Clinical Supervisors

## Solution-Orientated Supervision

Learn about a solution-orientated approach to supervision. This approach incorporates the best elements of empirically supported substance abuse counseling, capitalizes on what supervisees are doing right with their clients, and explores how to increase what works—and how to tap into the natural strengths, resources, and talents of even difficult clients to help them get “unstuck.” This approach fosters a cooperative partnership, which co-creates a supervisory climate that promotes supervisee skill development and professional growth. The solution-orientated supervision approach differs from many models of supervision that are hierarchical in nature and focus on problems.

## Overview

These four *updated* workshops share a solution-orientated approach to clinical supervision. The format of each day combines information-rich didactic presentations, case examples, and skill-building exercises. Each workshop meets the clinical supervisor training requirements of the Wisconsin Department of Safety and Professional Services (Chapter 440).
